COMMITTEE HEARING NOTICE- Revised Notice for Virtual Hearing

March 26, 2020

The Boston City Council's Committee on Government Operations will hold a public hearing on Tuesday, April 7, 2020 at 12:00 PM.

The subjects of the hearing are:

Docket #0100, petition for a special law re: An Act Authorizing Additional Licenses for the Sale of Alcoholic Beverages to be Drunk on the Premises in Boston (sponsored by Mayor Martin J. Walsh); and, Docket #0281, petition for a special law re: An Act Authorizing Additional Licenses for the Sale of Alcoholic Beverages to be Drunk on the Premises in Boston (sponsored by City Councilor Frank Baker). These matters were referred to the Committee on January 29, 2020.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

Attendance In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health accommodations and ensuring public access to its deliberations through adequate, alternative means.
