Dillon, Chief of Housing and Director, Department of Neighborhood Development The Department of Neighborhood Development (DND) is amending its Program Year 2019 Action Plan, covering the period July 1, 2019 to June 30,2020, to adjust the program budgets within a number of programs to create a **Small Business Relief Fund** (SBRF) within the Small Business Development unit of the Office of Economic Development (OED). The **SBRF** is in response to the negative impact to small businesses in Boston due to the Coronavirus Disease (COVID-19) pandemic.

Citizen Participation Process: The Substantial Amendment was prepared and submitted in accordance with the HUD waiver granted to expedite actions to respond to COVID-19. Specifically, the Citizen Participation Public Comment Period was 5-days rather than the standard 30-days. Notifications: DND emailed approximately 340 Policy News subscribers, individuals and organizations, on a list maintained for this purpose; and, notified 10,000 followers on the Department's Twitter and Facebook feeds. Notification of the Fund was emailed by the Mayor's Office of Economic Development to approximately 22,000 small businesses and interested parties in Boston including the networks within the 20 Boston Main Street Districts. The Small Business team held an informational conference call about the Fund on April 7 that was accessible by a Facebook link, online via computer, or dialed in by telephone. The conference was well attended by more than 500 participants with the majority of questions centering around how to apply.

Summary of Public Comments: There was full support for the Fund from attendees on the April 7th conference call. The written comments (13) received are shown below.

East Boston Ecumenical Community Council (EBECC) stated that the Small Business Relief Fund should include non-profit organizations, particularly those working with immigrant communities, a key workforce population in Boston.	Non-profit organizations are not eligible under the Community Development Block Grant (CDBG) regulations for direct economic assistance such as this Small Business Loan program. CDBG regulations allow assistance to private, for-profit entities only.	

Programmatic Budget Changes: This Amendment reduces \$1,819,000 in CDBG funds to six programs. Details of the budget changes are included below. We do not anticipate that these budget changes will have a negative impact on these programs as the CDBG funds are not currently committed to projects. Further, we are in the last quarter of the budget cycle and remaining funds in each program's budget will be returned and redistributed for the start of the new program year on July 1.
