The Boston City Council's Committee on Ways & Means will hold a public hearing on Monday, May 4, 2020 at 9:00 AM. This hearing will be held virtually via Zoom.

The subject of the hearing is:

***Docket #0649, message and order authorizing the City of Boston to accept and expend the amount of One Hundred Twenty Million Eight Hundred Fifty-Three Thousand Three Hundred Fifty-Nine Dollars and Ten Cents (\$120,853,359.10) in the form of a grant, awarded by the United States Department of the Treasury to be administered by the City of Boston, from the Coronavirus Relief Fund established by section 5001 of the CARES ACT.***

This matter was sponsored by Mayor Martin J. Walsh and was referred to the Committee on April 29, 2020.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

**Attendance** In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate, alternative means.
