#### **Councilor Kenzie Bok, Chair, asked:**

- DND has taken on more responsibility and more projects over the past few years, but over the same period there has been a slight decline in FTEs. Is the department at the right staff capacity to handle this infusion of resources and get these important projects done with the necessary speed?

- Please provide updates on the design of the city housing voucher program; in particular, please discuss the ways in which it can be geared to fill holes in who is served by the federal and state housing voucher programs.

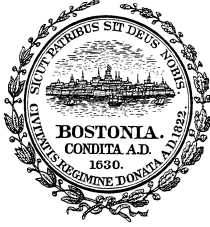

countercyclical strategy over the next few years ahead? It strikes me that there are many backlogged maintenance projects at BHA that could be quickly ready to go if funding is available, and spending city capital dollars on public housing preservation and creation may help free up resources in the housing development pipeline.

### Councilor Liz Breadon asked:

- DND has a significantly increased budget for FY21, what are the priorities for increase?

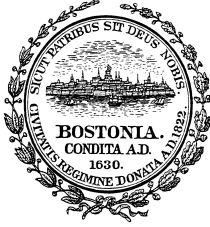
