






Most people who answered this survey live within 5 or 10 minute walk of the Urban Wilds.




Most people who answered the survey visit the park several times a year, with many visiting once a week or more.


People visit the park throughout the entire year, but Spring and Fall are more popular seasons to visit.




Selwyn Street/ Robken Road is the most popular entrance.


People who answered usually exit from Selwyn Street/ Robken Road or Hazelmere Road.








People have seen so many different types of plants and animals within the Urban Wild!


The most mentioned were difference species of birds, including ducks, woodpeckers, oreoles, red wing blackbird, and hawks!




Most people reported that they see 1-2 other people when visiting the Roslindale Wetlands.




50% of people who answered said improving muddy trails would increase their visits.


The most frequently cited changes that people feel would "greatly improve" their experience are:



#### The Wetlands are an Important Resource:

- -Under-appreciated, under-utilized, under-managed resource
- -Nearby schools should use for education
- -It's had an important role providing outdoor space during the pandemic!
- -It's a nice conterpart to the often busy arboretum

#### Continue to Push for Parcel Aquisition and Conservation:


- -Concern over housing development (on private parcels)
- -City should actively pursue acquiring private parcels for conservation
- -Acquire 104 Walter Street, remove hazard buildings for safety


#### **Conservation Concerns:**

- -Balancing accessibility with wildlife and natural preservation
- -Need for coordination between the Arboretum over spreading invasives (Caster-Aralia tree)
- -Signage for dog regulations (requires leashes)
- -Trash cans at entrances with dog waste bags
- -Provisions for low impact use, no interpretive signage

#### Maintence and Design Suggestions:

- -Include signs with information on tick and mosquito bite safety
- -Make part of Emerald Necklace (it's basically an extension of Arboretum)
- -Needs on-going maintence efforts
- -Concern over harzard trees
- -More wayfinding at entrances
- -Interest in pollinator meadow or food forest on Coniston Paper Street
- -Children would enjoy more trails





In 1976, the Boston Redevelopment Authority published a document calling for the conservation of the city's Urban Wilds (143 areas throughout the city).


The Boston Conservation Comission aquirred private parcel through foreclosure: City as Eldon St I (1980s) and Eldon St II (mid 2000s).

In 2005, the Roslindale Wetlands Task Force requested the name be changed to the Roslindale Wetlands Urban Wild.












Roslindale Wetlands

- -Existing trail is not a loop, and it crosses onto private property.











-Trail behind Weld Street



-Large fallen tree (to play on)







-Trail parallel to Walter Street











Can you ask her to discuss the exit to Weld St. Is that narrow strip privately owned, I exit there all the time. It should be marked as public.

The neighbors have been active in the improvement work and are supportive of passage to Weld

Why is this loop needed?

Walking those routes are easy in the winter, especially if iced in.

Another un necessary "improvement"

Boardwalk the perimeter path not the cut across. Leave the middle undisturbed.

Were the non-human users consulted.?

This is great. could u repeat the access from weld st

I Like loop trail options--low impact boardwalks or stepping stones? Weld St entrance needs to be open and clear...

Anything to share about the ZFeeney development proposal. Possible to buy them out?

Placing a trail along the paper street through the heart of the wetlands would impinge heavily on animal habitat.

I see the Weld st entrance as a way to bring many more people in to enjoy the property. Weld st has lots of foot, bike and auto traffic. I do not like how this is being set-up to "keep the secret jewel" secret

Those trail proposals look great! Especially excited about the loop potential.

2. seems slippery for an environment that is so often wet. 4. seems like a more feasible option, but I'd love to see 6 for the wettest areas.

Any plans to remove encroachments?

I'd love to see as much native plants as possible, and removal of as must of the invasives as possible

I like the bog bridges! wonder whether raised stone dust would be high enough as the mud is really mucky in rainy times

no signage. no furnishings are needed.

Yes to picnic table!

Important consideration about the Feeney development proposal is that it is less then 100 feet from certified wetland. Also, the lay of the land from Walter past the barn is rain water run off. As climate change brings heavier rains it will flood over at times. Do not see how they can build anywhere in there.

what about bike racks - unfortunately there are no bikes allowed

I love 20, 22, and 23. I'd also like to see some "Keep Dogs on Leash" signage.

Native pollinators & wildflowers would be great (Jim Taff

I'd love to see features to support birds and bats - bat houses? Bird houses?

I like the more rustic solutions: stepping stones, rough stone bench.

More sinage the better - descrete is ok

Love your ideas overall

I like the stone dust rail for its accessibility

I think an important consideration in planning is that this is a small parcel that does have some wildlife. OUr improvements should minimize disruption to wildlife.

minimal, naturalistic treatment for trails versus stonedust and pricey wooden ones

Yes please please clear out the entrance on Coniston Road. We'd love a picnic table and or place for people to hang out and enjoy the wilds entrance.

Never tried the Weld entrance but wonder whether it would put a lot of foot traffic through the neighbors' homes

It'd be useful to know what effects the proposed improvements would have on the wetlands \_as a wetlands\_ given the importance of wetlands in climate/flooding mitigation

I think you should plan for a Walter Street entrance, and how to incorporate 108 Walter. Your plan should recommend inclusion of 108 Walter. The trail as you outlined seems tight and should be a little farther to the southeast.

We removed even more debris when did major clean up 15 years ago.

Would like to have some different trail options, so it's not the same walk every time.

Complete the larger Eldon-side loop trail as the priority, with a strong boardwalk for durability and stepping stones through muddy patches where needed. Minimal and strong furniture (granite bench, granite sign post, one or two interpretive signs). Invasive trees and knotweed removal and native tree plantings with native polinators. This project likely won't get significant ongoing maintenance or major investments, so the things built should be simple and durable. A simple reasonably dry loop route around the wetlands is the goal-people protect what they love.
