## COMMITTEE HEARING NOTICE - Virtual Hearing

July 21, 2020

The Boston City Council's Committee on Government Operations will hold a public hearing on Thursday, August 6, 2020 at 10:00 AM. This hearing will be held virtually. The subject of the hearing is: **Docket #0851, order for an amendment to the Boston City Charter pursuant to G.L. c. 43B, §10(b).** This matter was sponsored by Councilor Lydia Edwards and was referred to the Committee on July 8, 2020.

NOTICE: The Boston City Council may have a quorum participating due to standing committees of the City Council consisting of both voting and non-voting members. However, members participating in this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

**Attendance** In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health accommodations and ensuring public access to its deliberations through adequate, alternative means.
