COMMITTEE HEARING NOTICE

July 17, 2020

The Boston City Council's Committee on Public Safety & Criminal Justice will hold a public hearing on **Thursday, July 23, 2020 at 9:30 AM**. This hearing will be held virtually.

The subjects of the hearing are:

Docket #0408, message and order authorizing the City of Boston to accept and expend the amount of Eight Hundred Fifty Thousand Dollars (\$850,000.00) in the form of a grant for the FY20 Boston Regional Intelligence Center Earmark, awarded by the MA Executive Office of Public Safety and Security, to be administered by the Police Department.

Docket #0710, message and order authorizing the City of Boston to accept and expend the amount of Thirty Thousand Seven Hundred Twenty-Two Dollars and Ninety-One Cents (\$30,722.91) in the form of a grant for the Federal FY16 Innovations in Community Based Crime Reduction (formerly the Byrne Criminal Justice), passed through the Boston Public Health Commission, to be administered by the Police Department.

Docket #0752, message and order authorizing the City of Boston to accept and expend the amount of One Million Two Hundred Ninety-Seven Thousand Seven Hundred Fifty-Eight Dollars (\$1,297,758.00) in the form of a grant, for the FY20 Coronavirus Emergency Supplemental Funding, awarded by the United States Department of Justice to be administered by the Police Department.

Docket #0831, message and order authorizing the City of Boston to accept and expend the amount of One Hundred Twenty Thousand Dollars (\$120,000.00) in the form of a grant for the Harrison Albany Block Public Benefits Fund, awarded by the Boston Redevelopment Authority, to be administered by the Boston Police Department.

These matters were sponsored by Mayor Martin J. Walsh, and were referred to the Committee on February 26, May 20, June 10, and July 8, 2020, respectively.
