## COMMITTEE HEARING NOTICE

November 18, 2020

The Boston City Council's Committee on Public Health will hold a public hearing on **Monday, December 14, 2020 at 2:00 PM**. This hearing will be held virtually.

The subject of the hearing is:

***Docket #1036, message and order authorizing the City of Boston to accept and expend the amount of Four Hundred Ninety-Eight Thousand Two Hundred Ninety-one Dollars (\$498,291.00) in the form of a grant for the First Responders-Comprehensive Addiction and Recovery Act Cooperative Agreement, awarded by the U.S. Health and Human Services to be administered by the Fire Department.***

This matter was sponsored by Mayor Martin J. Walsh, and was referred to the Committee on October 7, 2020.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

**Attendance** In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate, alternative means.
