COMMITTEE HEARING NOTICE

November 6, 2020

The Boston City Council's Committee on Public Health and Committee on Planning, Development and Transportation will hold a joint public hearing on **Monday**, **November 23, 2020 at 3:00 PM**. This hearing will be held virtually.

The subjects of the hearing are:

Docket #1074, order for a hearing to discuss speeding cars as a public health emergency and address infrastructure improvements; and Docket #1040, order for a hearing to discuss pedestrian safety, traffic enforcement, and vision zero.

These matters were sponsored by Councilors Ed Flynn and Frank Baker (Docket #1074) and Councilors Ed Flynn, Kim Janey, and Kenzie Bok (Docket #1040). Docket #1074 was referred to the Committee on Public Health on October 28, 2020. Docket #1040 was referred to the Committee on Planning, Development and Transportation on October 7, 2020.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committees.

Attendance In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate alternative means.
