COMMITTEE HEARING NOTICE

November 9, 2020

The Boston City Council's Committee on Ways and Means will hold a public hearing on **Tuesday, November 17, 2020 at 2:00 PM**. This hearing will be held virtually.

The subject of the hearing is:

Docket #1085, Message and order approving an appropriation of One Hundred Eighty Two Million Eight Hundred Forty One Thousand Four Hundred Sixty Seven Dollars (\$182,841,467.00) for the purpose of paying costs of designing, constructing, equipping, and furnishing a new six story Josiah Quincy Upper School building at 900 Washington Street in the City of Boston, including the payment of cost incidental or related thereto.

Docket #1086, Message and order approving an appropriation of Eight Million Five Hundred Fifty Thousand Dollars (\$8,550,000.00) for the purpose of paying cost of designing, constructing, equipping, and furnishing a new six story Josiah Quincy Upper School building at 900 Washington Street in the City of Boston including the payment of costs incidental or related thereto.

This matter was sponsored by Mayor Martin J. Walsh, and was referred to the Committee on November 4, 2020.

This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate, alternative means.
