The Boston City Council's Committee on Public Health will hold a public hearing on **Tuesday, December 8, 2020 at 2:00 PM**. This hearing will be held virtually.

The subjects of the hearing are:

*Docket #0736, message and order for the confirmation of the reappointment of Manny Lopes, as a member of the Boston Public Health Commission's Board of Health for a term expiring on January 15, 2023.*

*Docket #0737, message and order for the confirmation of the appointment of Gualde Valdez, as a member of the Boston Public Health Commission's Board of Health for a term expiring on January 15, 2022.*

These matters were sponsored by Mayor Martin J. Walsh, and were referred to the Committee on June 3, 2020.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

**Attendance** In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate, alternative means.
