The Boston City Council's Committee on Strong Women, Families and Communities will hold a public hearing on **Thursday, April 8, 2021 at 1:00 PM**. This hearing will be held virtually.

The subject of the hearing is:

***Docket #0436, message and order authorizing the City of Boston to accept and expend the amount of One Hundred Thousand Dollars (\$100,000.00) in the form of a grant for CANshare FY2021, awarded by the Donor Group, to be administered by the Office of Food Access.***

This matter was sponsored by the Administration and was referred to the Committee on March 17, 2021.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.

This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate, alternative means.
