The Boston City Council's Committee on Government Operations will hold a hearing on **Monday, November 15, 2021 at 10:00 AM**. This hearing will be held virtually.

The subject of the hearing is:

***Docket #0900, ordinance to provide for legal representation of the Boston Groundwater Trust by the City of Boston Law Department.***

This matter was sponsored by Councilors Kenzie Bok, Michael Flaherty, and Lydia Edwards, and was referred to the Committee on August 18, 2021.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
