



INSTRUCTIONS FOR COMPLETING APPLICATION NOTICE OF INTENT – BOSTON NOI FORM

The Boston Notice of Intent Form is intended to be a supplement to the WPA Form 3 detailing impacts to locally designated wetland resource areas and buffer zones. Please read these instructions for assistance in completing the Notice of Intent application form. These instructions cover certain items on the Notice of Intent form that are not self-explanatory.

INSTRUCTIONS TO SECTION B: BUFFER ZONE AND RESOURCE AREA IMPACTS

Item 1. Buffer Zone Only. If you check the Buffer Zone Only box in this section you are indicating that the project is entirely in the Buffer Zone to a resource area **under both** the Wetlands Protection Act and Boston Wetlands Ordinance. If so, skip the remainder of Section B and go directly to Section C. Do not check this box if the project is within the Waterfront Area.

Item 2. The **boundaries of coastal resource areas** specific to the Ordinance can be found in Section II of the Boston Wetlands Regulations. You must also include the size of the proposed alterations (and proposed replacement areas) in each resource area.

Item 3. The **boundaries of inland resource areas** specific to the Ordinance can be found in Section II of the Boston Wetlands Regulations. You must also include the size of the proposed alterations (and proposed replacement areas) in each resource area.

INSTRUCTIONS TO SECTION C: OTHER APPLICABLE STANDARDS AND REQUIREMENTS

Item 1. Rare Wetland Wildlife Habitat. Except for Designated Port Areas, no work (including work in the Buffer Zone) may be permitted in any resource area that would have adverse effects on the habitat of rare, “state-listed” vertebrate or invertebrate animal species.

The most recent Estimated Habitat Map of State-Listed Rare Wetland Wildlife is published by the Natural Heritage and Endangered Species Program (NHESP). See:

If any portion of the proposed project is located within Estimated Habitat, the applicant must send the Natural Heritage Program, at the following address, a copy of the Notice of Intent by certified mail or priority mail (or otherwise sent in a manner that guarantees delivery within two days), no later than the date of the filing of the Notice of Intent with the Conservation Commission.

Evidence of mailing to the Natural Heritage Program (such as Certified Mail Receipt or Certificate of Mailing for Priority Mail) must be submitted to the Conservation Commission along with the Notice of Intent.

PROJECT NARRATIVE NOTES

Introduction

The proposed project is located at 65 Atlantic Avenue, Boston, MA. Calamari Waterfront Corp is seeking a permit to construct an open pergola on an existing courtyard space currently approved to be used for restaurant accessory use – Outdoor seating for 80 persons. A USGS location map is provided in Attachment B.

Existing Conditions

The lot at 65 Atlantic Avenue consists of an existing 3 story brick building and an open air outdoor courtyard consisting of a cobblestone patio, a brick paver walkway and several raised planter beds with cobblestone walls that are located on private property.

Project Goals

The primary purpose of the proposed project is to construct an approximately 80' by 17' open pergola frame onto a portion of the cobblestone patio located on the existing courtyard at 65 Atlantic Avenue to delineate the outdoor eating area.

Proposed Project


The proposed project consists of excavating approximately .55 square feet of existing paved courtyard surface area to install each of the six concrete sonotube supports for the pergola frame, as well as two supports for a small fenced enclosure.

FEMA

The proposed project is located in a FEMA Special Flood Hazard Area (Zone AE) with a Base Flood Elevation (BFE) of 10 feet NAVD88. The FEMA FIRMette images highlighting the project location can be found in Attachment E

Construction

Construction will consist of using a mini excavator or hand digging to remove the 8 designated cobblestones sections, including the compacted base beneath, to a depth of 4', then placing into each excavated section 10" sonotube forms to be filled with pre-mixed concrete to create the new supports. The area will be surface leveled and filled using portions of the excavated base material. Any leftover unused excavated base material will be removed offsite.



ARCHITECTS

Alternatives

Alternative #1 is to substitute the 8 concrete sonotube supports with Techno Metal Post helical piles installed by a certified technician using proprietary hydraulic machinery, eliminating the need to excavate any of the courtyard surface area. An analysis of the existing subsurface conditions would need to be done prior to installation to determine if the existing subsurface material is acceptable for helical piles and has adequate bearing capacity.

Coastal Resource Areas

Massachusetts DEP Wetlands Protection Act Regulations, 310 CMR 10.00

310 CMR 10.02 LAND SUBJECT TO COASTAL STORM FLOWAGE means land subject to any inundation caused by coastal storms up to and including that caused by the 100-year storm, surge of record or storm of record, whichever is greater.

The entire project is located within the Land Subject to Coastal Storm Flowage (LSCSF). The work is within FEMA AE Flood Zone with BFE 10' NAVD88. There are no performance standards pertaining to LSCSF at this time.

Climate Change Resilience/Sea Level Rise/Heat Island Effect

The small nature of the proposed project will not materially affect climate change, sea level rise or heat island effect. The use of outdoor seating for dining will be an enhancement to the Harborwalk area as an important public amenity. The placement of outdoor seating will minimally improve the heat absorption of the current cobblestone surfacing in the courtyard. The frame and supports are also able to weather sea level rise and storm events, and will be functional during periods of disruption. Use of the courtyard for outdoor dining would reduce the interior lighting and heating/cooling loads during peak hours.

Summary

The proposed project will enhance public space and does not increase impact to wetland resource areas.

The project does not materially alter any existing resource areas, nor does the project materially alter any existing stormwater patterns.


Furthermore, the replacement of approximately .55 square feet of existing non-porous cobblestone pavers for each support with .55 square feet of non-porous concrete supports is a de minimis modification to the existing surface area of the courtyard; amounting to a net modification of less than 0.05% (5/100 of 1%) of the lot's total resource area. To put into perspective how minimal the overall change to compensatory storage the supports would displace, lowering of the existing cobblestone surface by 1/16", an amount not feasibly measurable, would provide almost double the compensatory storage lost.


PERGOLA FRAME DETAIL ELEVATION



**PROJECT NARRATIVE NOTES**

**Introduction**

The proposed project is located at 65 Atlantic Avenue, Boston, MA. Calamari Waterfront Corp is seeking a permit to construct an open pergola on an existing courtyard space currently approved to be used for restaurant accessory use – Outdoor seating for 80 persons. A USGS location map is provided in Attachment B.

**Existing Conditions**

The lot at 65 Atlantic Avenue consists of an existing 3 story brick building and an open air outdoor courtyard consisting of a cobblestone patio, a brick paver walkway and several raised planter beds with cobblestone walls that are located on private property.

**Project Goals**

The primary purpose of the proposed project is to construct an approximately 80' by 17' open pergola frame onto a portion of the cobblestone patio located on the existing courtyard at 65 Atlantic Avenue to delineate the outdoor eating area.

**Proposed Project**


The proposed project consists of excavating a total of approximately 4.4 square feet of existing paved courtyard surface area to install six concrete sonotube supports for the pergola frame, as well as two supports for a small fenced enclosure (.55 square feet each).

**FEMA**

The proposed project is located in a FEMA Special Flood Hazard Area (Zone AE) with a Base Flood Elevation (BFE) of 10 feet NAVD88. The FEMA FIRMette images highlighting the project location can be found in Attachment E

**Construction**

Construction will consist of using a mini excavator or hand digging to remove the 8 designated cobblestones sections, including the compacted base beneath, to a depth of 4', then placing into each excavated section 10" sonotube forms to be filled with pre-mixed concrete to create the new supports. The area will be surface leveled and filled using portions of the excavated base material. Any leftover unused excavated base material will be removed offsite.

## Alternatives

Alternative #1 is to substitute the 8 concrete sonotube supports with Techno Metal Post helical piles installed by a certified technician using proprietary hydraulic machinery, eliminating the need to excavate any of the courtyard surface area. An analysis of the existing subsurface conditions would need to be done prior to installation to determine if the existing subsurface material is acceptable for helical piles and has adequate bearing capacity.

## Coastal Resource Areas

### Massachusetts DEP Wetlands Protection Act Regulations, 310 CMR 10.00

310 CMR 10.02 LAND SUBJECT TO COASTAL STORM FLOWAGE means land subject to any inundation caused by coastal storms up to and including that caused by the 100-year storm, surge of record or storm of record, whichever is greater.

The entire project is located within the Land Subject to Coastal Storm Flowage (LSCSF). The work is within FEMA AE Flood Zone with BFE 10' NAVD88. There are no performance standards pertaining to LSCSF at this time.

### Climate Change Resilience/Sea Level Rise/Heat Island Effect

The small nature of the proposed project will not materially affect climate change, sea level rise or heat island effect. The use of outdoor seating for dining will be an enhancement to the Harborwalk area as an important public amenity. The placement of outdoor seating will minimally improve the heat absorption of the current cobblestone surfacing in the courtyard. The frame and supports are also able to weather sea level rise and storm events, and will be functional during periods of disruption. Use of the courtyard for outdoor dining would reduce the interior lighting and heating/cooling loads during peak hours.

## Summary

The proposed project will enhance public space and does not increase impact to wetland resource areas.

The project does not materially alter any existing resource areas, nor does the project materially alter any existing stormwater patterns.

Furthermore, the replacement of approximately .55 square feet of existing non-porous cobblestone pavers for each support with .55 square feet of non-porous concrete supports, totalling 4.4 square feet, is a de minimis modification to the existing surface area of the courtyard; amounting to a net modification of less than 0.05% (5/100 of 1%) of the lot's total resource area. To put into perspective how minimal the overall change to compensatory storage the supports would displace, lowering of the existing cobblestone surface by 1/16", an amount not feasibly measurable, would provide almost double the compensatory storage lost.
