Re: **Certificate of Compliance: Morrissey Boulevard Tide Gate Project**

Dear Executive Director Moreno and Commissioners,

On behalf of the applicant, the Massachusetts Department of Conservation and Recreation (DCR), Vanasse Hangen Brustlin, Inc. (VHB) is submitting the enclosed Certificate of Compliance (COC) for the installation of six inline tide gates at four locations along Morrissey Boulevard (the Project) in the Dorchester neighborhood of Boston, MA (the Project Site). This application is being filed under the Massachusetts Wetlands Protection Act, MGL c.131, §40 (WPA) and its implementing regulations (310 CMR 10.00) and the Boston Wetlands Ordinance (the Ordinance). A check made payable to the City of Boston in the amount of \$100.00 has been mailed separately for payment of the Certificate of Compliance fee.

The Project performed work within Land Subject to Coastal Storm Flowage (LSCSF) and the 100-foot Buffer Zone to Coastal Bank and Coastal Beach as regulated by the WPA. Work was also performed within the 25-foot Waterfront Area as regulated by the Ordinance.

During construction, changes were made to the locations of the proposed tide gates and associated drainage manholes due to conflicts with an existing gas line. On the plans, the gas line is shown approximately 3' offset of the proposed manholes, but in actuality, the gas line was much closer to the proposed work. Therefore, in two of four locations, the proposed work was shifted at the request of the gas company. VHB and DCR did a post-construction site walk and visually observed the completed project. Changes to the work are summarized below:

- Location 1: The location of the drainage manhole and tide gate was relocated approximately 97' south of the proposed location to avoid excess digging & stockpiling. The work was located approximately the same distance away from the Coastal Bank and wetland flags.
- Location 2: No change, work zone had a smaller limit of work than proposed.
- Location 3: The gas company requested the work be conducted away from their main, therefore the drainage manhole & tide gate were relocated approximately 7' east of the proposed location. The proposed work could not be shifted west due to an existing drainage manhole. The proposed work moved closer to the coastal bank but kept outside of the delineated Coastal Bank area.
- Location 4: The gas company requested the work be conducted away from their main, therefore the drainage manhole & tide gate were relocated approximately 17' west of the proposed location. This is further away from the Coastal Bank.



As-builts are provided in this submission with applicable dimensions. All dimensions were taken in the field and are to be considered approximate since they were not surveyed. A VHB professional engineer, Jill Baumbach, has stamped the as-builts and is certifying that, to the best of her knowledge, what is shown on the as-builts match what she visually observed in the field.

On behalf of the applicant, the Massachusetts Department of Conservation and Recreation (DCR), Vanasse Hangen Brustlin, Inc. (VHB) is submitting the enclosed Certificate of Compliance (COC) for the installation of six inline tide gates at four locations along Morrissey Boulevard (the Project) in the Dorchester neighborhood of Boston, MA (the Project Site). This application is being filed under the Massachusetts Wetlands Protection Act, MGL c.131, §40 (WPA) and its implementing regulations (310 CMR 10.00) and the Boston Wetlands Ordinance (the Ordinance). A check made payable to the City of Boston in the amount of \$100.00 has been mailed separately for payment of the Certificate of Compliance fee.

The Project performed work within Land Subject to Coastal Storm Flowage (LSCSF) and the 100-foot Buffer Zone to Coastal Bank and Coastal Beach as regulated by the WPA. Work was also performed within the 25-foot Waterfront Area as regulated by the Ordinance.

During construction, changes were made to the locations of the proposed tide gates and associated drainage manholes due to conflicts with an existing gas line. On the plans, the gas line is shown approximately 3' offset of the proposed manholes, but in actuality, the gas line was much closer to the proposed work. Therefore, in two of four locations, the proposed work was shifted at the request of the gas company. VHB and DCR did a post-construction site walk and visually observed the completed project. Changes to the work are summarized below:

- Location 1: The location of the drainage manhole and tide gate was relocated approximately 97' south of the proposed location to avoid excess digging & stockpiling. The work was located approximately the same distance away from the Coastal Bank and wetland flags.
- Location 2: No change, work zone had a smaller limit of work than proposed.
- Location 3: The gas company requested the work be conducted away from their main, therefore the drainage manhole & tide gate were relocated approximately 7' east of the proposed location. The proposed work could not be shifted west due to an existing drainage manhole. The proposed work moved closer to the coastal bank but kept outside of the delineated Coastal Bank area.
- Location 4: The gas company requested the work be conducted away from their main, therefore the drainage manhole & tide gate were relocated approximately 17' west of the proposed location. This is further away from the Coastal Bank.



As-builts are provided in this submission with applicable dimensions. All dimensions were taken in the field and are to be considered approximate since they were not surveyed. A VHB professional engineer, Jill Baumbach, has stamped the as-builts and is certifying that, to the best of her knowledge, what is shown on the as-builts match what she visually observed in the field.

Dear Executive Director Moreno and Commissioners,

I, Jill Baumbach, a Professional Engineer licensed in the state of Massachusetts, has stamped the as-builts and am herein certifying that, to the best of my knowledge and through a visual inspection of the completed post-construction site on April 15, 2022, work was completed in substantial compliance with the plans (aside from the listed changes below) and in accordance with the Order that was issued.

VHB previously submitted As-Builts to the Commission that visually depict the on-site changes compared to the proposed plans. During construction, changes were made to the locations of the proposed tide gates and associated drainage manholes due to conflicts with an existing gas line. On the plans, the gas line is shown approximately 3' offset of the proposed manholes, but in actuality, the gas line was much closer to the proposed work. Therefore, in two of four locations, the proposed work was shifted at the request of the gas company. VHB and DCR did a post-construction site walk on April 15, 2022 and visually observed the completed project. All dimensions were taken in the field and are to be considered approximate since they were not surveyed.

Changes to the work are summarized below:

- Location 1: The location of the drainage manhole and tide gate was relocated approximately 97' south of the proposed location to avoid excess digging & stockpiling. The work was located approximately the same distance away from the coastal bank and wetland flags.
- Location 2: No change, work zone had a smaller limit of work than proposed.
- Location 3: The gas company requested the work be conducted away from their main, therefore the drainage manhole & tide gate were relocated approximately 7' east of the proposed location. The proposed work could not be shifted west due to the presence of an existing drainage manhole. The proposed work moved closer to the coastal bank but did keep outside of the delineated coastal bank area.
- Location 4: The gas company requested the work be conducted away from their main, therefore the drainage manhole & tide gate was relocated approximately 17' west of the proposed location. This is further away from the coastal bank.
