Docket #0354 – Message and order for the confirmation of the reappointment of Philomin Laptiste, as a member of the Boston Public Health Commission's Board of Health for a term expiring on January 15, 2025.

Docket #0577 – Message and order for the confirmation of the appointment of Greg Wilmont as a member of the Boston Public Health Commission's Board of Health, for a term expiring January 15, 2025.
