TO THE CITY COUNCIL

Dear Councilors:

I transmit herewith a supplemental appropriation order for various departments for FY23 in the amount of \$2,072,216 to cover the FY23 cost items contained within the collective bargaining agreements between the City of Boston and SEIU, Local 888, Citywide. The terms of the contracts are October 1, 2020 through June 30, 2023. The major provisions of the contracts include base wage increases of 2%, 1.5% and 2% effective the first pay period of January of each fiscal year.

As originally presented to you, the FY23 budget request included a Reserve for Collective Bargaining - a separate appropriation to fund projected collective bargaining increases. A separate order has been filed to reduce that appropriation to support this supplemental request.

I respectfully request your support of this supplemental appropriation.

ORDERED: That in addition to the appropriations heretofore made, to meet the current operating expenses of the fiscal period commencing July 1, 2022 and ending June 30, 2023, the sum of TWO MILLION, SEVENTY TWO THOUSAND, TWO HUNDRED SIXTEEN DOLLARS (\$2,072,216) be, and the same hereby is appropriated as follows, said sum to be met from available funds and taxation pursuant to Section 23 of Chapter 59 of the General Laws: -
