Proposed Work: Remove existing vinyl siding and replace with 6 inch wood siding.

Applicant: Antonio Perez

Proposed Work: New storefront signage.

II. ADMINISTRATIVE REVIEW

In order to expedite the review process, the commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to commission staff pending ratification at its monthly public hearing. **Having been identified**



as meeting these eligibility criteria and all applicable guidelines, the following applications will be approved at this hearing:

► Applicants whose projects are listed under this heading **NEED NOT APPEAR** at the hearing. Following the hearing, you will be issued a Determination Sheet to present at the Inspectional Services Department (1010 Massachusetts Avenue) as proof of project approval when applying for permits. ISD personnel will send an electronic copy of your building-permit application to the commission staff for review. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

► **PLEASE NOTE THAT FOLLOWING ISSUANCE OF THE DETERMINATION SHEET NO FURTHER CORRESPONDENCE WILL BE ISSUED FOR THE APPLICATIONS LISTED BELOW.** The electronic building-permit application as annotated by commission staff will constitute your Certificate of Appropriateness; this will be valid for two years from the date of the approval letter. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.

APP #: 23.1063 AB 4 CHISWICK ROAD: Spot repointing and masonry repairs to match the existing facades using Conproco Matrix mortar, repaint entryways in kind using Conprolastic color. Fabricate and install 16oz red copper flashing on each arch above the front entryway. Red copper flashing will not cover any architectural features.

APP #: 23.1085 AB 1634-1638 COMMONWEALTH AVENUE: Masonry repairs to three window lintels and eight window sills, parapet wall. All conditions to be repaired to match historic profile, tooling and material.
