The Boston City Council's Committee on Strong Women, Families, & Communities will hold a hearing on **Thursday, March 7, 2024 at 10:00 AM** in the **Iannella Chamber, 5th floor, Boston City Hall.**

Docket #0376, Message and order authorizing the City of Boston to accept and expend the amount Two Million Two Hundred Thirty-Two Thousand One Hundred Fifty-Two Dollars (\$2,232,152.00) in the form of a grant for the Federal FY24 Title III-C Nutrition Service Program, awarded by the U.S. Department Health and Human Services, passed through the MA Executive Office of Elder Affairs, to be administered by the Age Strong Commission. The grant will fund nutrition services for older adults in the City of Boston.

The grant will fund Caregiver Services for older adults in the City of Boston.

The grant will fund the cost for administration of Title III programs.

The grant will fund consumer protection programs to improve long-term services for older adults in the City of Boston.


