The Boston City Council's Committee on Housing and Community Development will hold a hearing on **Tuesday, July 30, 2024 at 2:00 PM** in the **Iannella Chamber, 5th floor, Boston City Hall.** 

The subject of the hearing is:

Docket #0633, Message and order for your approval an Order authorizing the City of Boston, acting through its Mayor's Office of Housing, to accept and expend payments in the amount of Forty Million Dollars (\$40,000,000.00) given to the City of Boston's Inclusionary Development Policy Fund. The City of Boston's Inclusionary Development Policy Fund. The City of Boston's Inclusionary Development Fund (IDP) was established by Executive Order in February 2000 to support the production and preservation of affordable housing in new market rate housing developments.

Docket #0695, Message and order authorizing the City of Boston to accept and expend the amount of Five Million Dollars (\$5,000,000.00) in the form of a grant to provide rapid rehousing services together with wraparound support and recovery services to individuals, with a history of homelessness, awarded by the MA Department of Public Health to be administered by the Mayor's Office of Housing. The grant will fund State ARPA Earmark Mayor's Office of Housing.

These matters were sponsored by Mayor Michelle Wu and referred to the Committee on April 3, 2024 and April 10, 2024.
