PHC 1. On a joint petition by the City of Boston Transportation Department and the City of Boston Public Works Department for the making of **Specific Repairs** within the following public ways in South Boston, consisting of curb realignment, roadway and sidewalk reconstruction, as well as new and relocated pedestrian ramps, traffic signal infrastructure, street lighting infrastructure, hydrants, driveway curb cuts, raised crosswalks, protected bicycle facilities, and median islands:

- Old Colony Avenue generally between Joseph Agri Street and Mitchell Street;
- Dorchester Street generally between Tuckerman Street and Rev. Richard A. Burke Street;
- Mitchell Street generally at Old Colony Avenue.

Public Hearing

PH 1. On a petition by the President and Fellows of Harvard College for the **Line & Grade Approval** of a new public way in Brighton to be known as **Trotting Avenue**, located generally east of Stadium Road, from Western Avenue to a point approximately 631 feet southerly.

(NB 10/10/2024) As shown on a set of plans entitled "City of Boston Public Works Department, Engineering Division, Line and Grade Plan, Trotting Avenue, Public Way, Allston," 4 sheets dated September 19, 2024.

PH 2. On a petition by the President and Fellows of Harvard College for the **Line & Grade Approval** of a new public way in Brighton to be known as **Milestone Street**, located generally west of Soldiers Field Road, from Western Avenue to a point approximately 647 feet southerly.

(NB 10/10/2024) As shown on a set of plans entitled "City of Boston Public Works Department, Engineering Division, Line and Grade Plan, Milestone Street, Public Way, Allston," 4 sheets dated September 19, 2024.

PH 3. On a petition by the President and Fellows of Harvard College for the **Layout Approval** of a new private way (open to public travel) in Brighton to be known as **Axle Way**, located between the southerly terminus of Trotting Avenue and the southerly terminus of Milestone Street.

PH 6. On a petition by the President and Fellows of Harvard College for the **Vertical Discontinuance** of portions of **Milestone Street** (public way), Brighton, located generally between Western Avenue and Axle Way, vertically beneath the grades of the roadways and sidewalks.

(NB 10/10/2024) As shown on a plan entitled "City of Boston Public Works Department, Engineering Division, Vertical Discontinuance, Milestone Street, Public Way, Allston," 1 sheet dated November 7, 2024.

PH 7. On a petition by the Trustees of Boston University for the making of **Specific Repairs** within **Commonwealth Avenue** (public way), Boston Proper, located on its southerly side at address no. 700 generally across from Granby Street, consisting of curb realignment, sidewalk reconstruction with structural soil, as well as new and relocated pedestrian ramps, specialty pavement, street lighting infrastructure, street trees, planters, landscaping, stormdrain infrastructure, bike racks, and raised crosswalks.

On a petition by Residences at 1471 Blue Hill Limited Partnership for the making of **Specific Repairs** within the following public ways in Dorchester, consisting of curb and sidewalk reconstruction, as well as new and relocated pedestrian ramps, specialty pavement, street lighting infrastructure, street trees, planters, landscaping, green stormwater infrastructure, bike racks, and driveway curb cuts:
 - Blue Hill Avenue at address no. 1471, generally north of Woodhaven Street;
 - Culbert Street northwest of Woodhaven Street;
 - Woodhaven Street generally at Blue Hill Avenue/Culbert Street.
