Overview

The Boston Public Health Commission (BPHC) is the local public health department for the City of Boston. BPHC's mission is to work in partnership with communities to protect and promote the health and well-being of Boston residents, especially those impacted by racism and systemic inequities.

BPHC's Homeless Services Bureau (HSB) operates the two largest congregate shelters in New England, serving over 4,000 unique individuals annually. As part of its service portfolio, HSB operates three commercial kitchens in Boston, preparing approximately 2,500 meals daily for guests at BPHC shelters.

Regulatory Compliance and Equity Considerations

Compliance with the City of Boston's Living Wage Ordinance: All service contracts issued by BPHC are subject to the City of Boston's Living Wage Ordinance. This ordinance requires that employees working on substantial city contracts receive an hourly wage that ensures a family of four can live at or above

the federal poverty level. This wage amount, called the living wage, is recalculated annually. For additional information, refer to Living Wage Division.

System for Award Management: The Boston Public Health Commission (BPHC) is prohibited from contracting with or making subawards under covered transactions to parties that are suspended or debarred, or whose principals are suspended or debarred by the federal government. BPHC will ensure compliance with the code of federal regulation via confirmation from the Federal System for Award Management (SAM). The System for Award Management (SAM) catalogs vendors registered with the US Federal Government and identifies those who may be subject to any active exclusions, disqualifications, or are otherwise ineligible from receiving funds.

BPHC Standard Contract: Awarded vendor(s) will be subject to the terms and conditions outlined in the contract which define obligations and responsibilities. Services shall not commence until both parties have duly executed the contract.

Commitment to Equitable Procurement: BPHC is dedicated to fostering equitable procurement practices and encourages submissions from Certified Underrepresented Business Enterprises (CUBE). This includes Minority-owned Business Enterprises (MBE), Women-owned Business Enterprises (WBE), Veteran-owned Business Enterprises (VBE), Disability-owned Business Enterprises (DOBE), Lesbian, Gay, Bisexual, and Transgender Business Enterprises (LGBTBE), Minority Non-Profit Organizations (MNPO), Women Non-Profit Organizations (WNPO), Minority Women Non-Profit Organizations (MWNPO), and local businesses.

Scope of Work

The Homeless Services Bureau is seeking qualified vendors that can support routine repairs and maintenance on various existing commercial service equipment including but not limited to the following duties:

- Schedule and provide routine repair and maintenance services for all commercial-grade equipment
- Respond to non-emergency repair requests within 24 hours and emergency repair requests within 5 hours
- Assign a site supervisor(s) who is accessible
- Provide quotes for new equipment at BPHC's request

In the event an equipment is deemed beyond repair, the vendor shall be able to recommend a make and model to the current equipment

Repair and maintenance requests shall be carried out on an as-needed basis, rather than pursuant to a predetermined schedule. BPHC reserves the right to solicit quotations for equipment beyond the scope of those specified herein.

Vendor(s) may be responsible for making the same day service available upon request (i.e., in emergency cases) and at the cost set forth within the price sheet. Additionally, the vendor(s) should provide 24/7 emergency contact information.

Vendor Walk-Through Details

Attendance at the walk-through is not mandatory but is highly recommended to facilitate accurate cost assessments for repairs and/or maintenance. This will provide a comprehensive understanding of each site's specific needs, and by participating, vendors can better tailor the submission process. The walkthroughs shall proceed in the following order: Emergency Shelter, followed by Woods Mullen Shelter, and concluded at Quincy Street Kitchen.

Vendors may not ask questions during the walkthrough; rather, all questions shall be submitted to RFR@bphc.org with the subject "Commercial Equipment Maintenance and Repair." Questions are due by Wednesday, April 9, 2025, at 5:00 PM (review timeline and activities above)

Terms of Services

Services are anticipated to begin on or about May 1, 2025, and extend through June 30, 2026, for the initial contract term. The contract includes two additional years, subject to the same terms and conditions for each renewal period. BPHC may select one or multiple vendors to provide services. No services shall commence until all necessary contract documentation is fully executed by BPHC and the awarded vendor(s).

The contract may be terminated with written notification by either party with or without cause within ninety (90) days by mutual agreement or in the event of substantial failure to perform in accordance with the terms set forth in the contract. BPHC reserves the right to select the next responsible and responsive vendor at its discretion.

Submission Instructions

The pricing sheet shall be fully completed for all listed equipment. If pricing cannot be determined, indicate as "N/A."

Requested documents within this RFQ shall be submitted as a single PDF document and must include the following:

- 1. Cover Page
 - Company Profile
 - Contact Personnel
 - Certified Underrepresentative Business Enterprises (CUBE) classification Optional
- 2. Justification Not to exceed 3 pages
 - Outline a detailed approach for delivering the required services as specified in the scope of work (page 3)
 - Brief history of the company and its experience in commercial equipment repair, maintenance, and supply services
 - Incorporate labor cost
 - Provide the company's/entity's plan of action or response in the event of an emergency that hinders or prevents the performance of services as outlined in the RFQ
- 3. Price Sheet A fillable document (pages 5 -6) shall be completed for the estimated cost of repair and maintenance cost
- 4. Provide three business references relevant for which similar work has been performed, including the following details for each:
 - a. Business Name
 - b. Contract Duration
 - c. Contact Personnel
