Utility Pole Hearing Continued

UPC 1. On a petition by Verizon New England Inc. for a **Utility Pole Installation** to install one new private utility pole within **Nazing Street**, Roxbury, to be located on its southwesterly side at address nos. 36-38, generally between Blue Hill Avenue and Maple Street. (UP 6/12/2025; UPC 6/26/2025)

Utility Pole Hearing

UP 1. On a petition by Eversource Energy for a **Utility Pole Installation** to install one new private utility pole with a guy wire attachment within **Harvard Street**, Dorchester, to be located on its northerly side at address no. 85, generally across from Spencer Street.

UP 2. On a petition by Eversource Energy for a **Utility Pole Installation** to install one new guy wire attaching to an existing private utility pole within **Union Street**, Charlestown, to be located on its southeasterly side at the side of 116 Main Street, generally southwest of Main Street.

UP 3. On a petition by Eversource Energy for a **Utility Pole Installation** to install one new guy wire attaching to an existing private utility pole within **Moulton Street**, Charlestown, to be located on its southeasterly side generally northeast of Corey Street.

Public Hearing

PH 1. On a petition by the City of Boston Public Works Department for the making of **Specific Repairs** within the following public ways in Dorchester:

- **Babson Street** – at Delhi Street;
- **Delhi Street** – between Babson Street and Crossman Street;
- **Crossman Street** – southeast of Delhi Street.

(NB 6/26/2025) As shown on a set of plans entitled “City of Boston Public Works Department, Engineering Division, Specific Repair Plan, Neighborhood Slow Streets Program, Babson Street, Crossman Street, Delhi Street, Mattapan,” 4 sheets dated July 2, 2025.

PH 2. On a joint petition by Bunker Hill Landco LLC and the Boston Housing Authority for the granting of an **Earth Retention License** for the installation of a temporary earth support system within the following roadways in Charlestown:

- **Samuel Morse Way** (private way open to public travel) – on its southwesterly side at address no. 30, between Decatur Street and Corey Street;
- **Decatur Street** (public way) – on its northwesterly side between Samuel Morse Way and Moulton Way.
