Chapter 111, Section 31C, and pursuant to the Building Emissions Reduction and Disclosure Ordinance, Boston City Code, Ordinances, Section 7-2.2, the City of Boston Air Pollution Control Commission will hold a **virtual public hearing at 2:30 p.m. on July 9, 2025**, to review the following projects to regulate and control air pollution so as to promote the public health and welfare of Boston residents.

Application for a Modified Downtown Boston Parking Freeze Permit from Biomed Realty on behalf of B9 LS Harrison & Washington LLC for 259 commercial spaces in a garage at 321 Harrison Avenue. This permit requests modification of an existing permit for 259 exempt parking spaces, to change the usage of the spaces to commercial parking. Issuance of permit would withdraw 259 spaces from the Downtown Boston parking freeze bank.
