**4:03PM**: Subcommittee Chair Berarducci called the Design Review public hearing to order. He explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public hearing was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. He also briefly explained how to participate in the online hearing. Boston City Councilor for District 8, Sharon Durkin made herself known. There were no members of the press present.

Following this brief introduction he called the first Design Review application.



#### I. DESIGN REVIEW SUBCOMMITTEE

Applicant: Helene Guezennec

Proposed Work: Renovation of existing Tool Shed and construction of a new Parks Facilities building. Minor landscape changes to accommodate new programming.

**PROJECT REPRESENTATIVES:** Maressa Perrault, Kyle Zick, and Brett Bentson were the project representatives. They presented the proposed scope of work to the Commission, which includes an overview of the proposal to construct a new Parks and Recreation facilities building and to renovate an existing tool shed.

**DOCUMENTS PRESENTED:** Documents presented included existing condition photographs, existing and proposed exterior elevation drawings, existing section drawings, scope of repairs photographs and drawings, viewpoint photographs of the proposed work from South, Charles Street crossing walk and the public garden suspension bridge. Documents presented also included the proposed site plan, proposed lighting plan, landscape plan, proposed fence drawings, landscape plan and material palettes, landscape site preparation plan.

**DISCUSSION TOPICS:** Discussion topics included an overview of the history and ornamentation of the existing structures, overview of previous proposals that came before the Commission, proposal adjustments concerning the trash removal and the driveway curb cut off, the proposal to renovate the existing building and provide new construction additions to the south elevations. Discussion regarding the necessity of having a facility for the Parks and Recreation department to maintain and operate within the park areas. The constraints regarding the expansion of the existing facilities due to existing specimen trees, a tool house, and Charles Street. The existing and proposed floor plans, an existing parking area, methods to protect the greenery during construction, existing greenery species,, the existing conditions of the area surrounding the existing building, changes to existing walking pathways and new accessible pathways, the new lighting fixtures, the new glass transoms, whether lighting will be continuous or discontinuous. The scope of repairs and removal to the existing building, paint colors, materials, and dimensions for replacement work and new additions, the existing and proposed fence, color palette for the existing building and proposed color scheme for new construction building and design details, visibility of the proposed work from each face, the heating and cooling system, no plan for signage.



COMMISSIONER COMMENTS AND QUESTIONS: During the Commissioner Comment and discussion period, the following topics were discussed in greater detail: the removal of the chimney from the existing building, lighting for the new addition, whether there will be a continuous strip of lighting or individual spots, whether the lighting will follow the outline of the pediment, material of the fence, whether the Parks Department and the Friends of the Public Garden agree with the proposed plant selections and treatment of plants surrounding the existing building, whether there would be signage, the maintenance separation, and the function of the gate door. Comments were offered regarding landscape elements, gardens and foundation planting, species of plants, the heat pump compressor and electric meter, and the construction makeup of walls on the new building.

**PUBLIC COMMENT:** During the public comment period, Boston City Councilor Sharon Durkan, submitted a written comment and spoke in support of the proposed work. Karen Mauney-Brodek, also spoke in support of the proposed work.

proposals that came before the Commission during Advisory Review, an overview of construction that is in and outside of their purview, the lease and property lines, areas that the Boston Public Schools are responsible for designing, community engagement efforts, the Clamshell wall, methods to preserve and protect the Clamshell wall during construction, a five step plan during demolition, the relationship between the existing structures and new additions, designs for the West Grandstand, stair and elevator accessibility in the stadium and Grove building, landscaped area details, native plant species and existing trees, the three light polls within their purview, an overview of climate goals, whether the building would explore solar options, new architectural structures visible from the Overlook, alternative building options for the Grove, existing condition of the Overlook, Overlook existing wall structure, material of the wall, the tunnel that going through the Overlook, relationship of the landform building. design details for the organic form and greenhouse building option, the cost estimate for the project.

Commissioner Comment and discussion period, the following topics were discussed in greater detail: Commissioners expressed concerns for the proposal included whether the proposed new buildings are obstructing the Overlook and expressed caution regarding the attractiveness of a glass structure being more transparent. Comments included the loss of a prominent feature such as the Overlook due to new building obstruction, preferences for design option two, the curved plan, the size of the proposed scoreboard and its visibility, the height and location of the lighting stations, the height of the new additions from the sidewalk to the roof. Commissioner questions focused on the purpose of the green house, whether the greenhouse would be used for indoor seating, whether the scoreboard could be relocated to the Northern side of the stadium, whether the applicant has reviewed any historic documentation about the color scheme and condition of the Clamshell wall, whether the appearance of the Clamshell will modified to meet code or safety requirements.

**PUBLIC COMMENT:** During the public comment period, the following participants offered public comments

Four members of the public submitted written comments and stressed the importance of a thorough review process rather than expediting this review process.

Barry Lawton, offered questions regarding the parking facilities and the track and



field facilities.

Charles Birnbaum, offered questions regarding the BLC guidelines and community engagement efforts also expressing concern regarding the lack of contextual analysis within the presentation.

Karen Mauney-Brodek, called for a MEPA review and spoke in support of restoring White Stadium. However they expressed concern regarding the applicants community engagement efforts and how the project is being reviewed and designed separately.

Sarah Freeman, requested that BLC public notices for hearings be posted on the Boston.gov events page.

Joshua Champagne, a representative from Boston City Councilor Tania Fernandes-Anderson's office, offered comments on behalf of Councilor Fernandes-Anderson which discussed rezoning, transportation, and the impact this project will have on the abutters.



Peat Duggin, expressed concern with the proposed scoreboard and offered comments regarding the historic nature of the park and noted that the park was made for Boston residents to have solace in nature.



Chief Mariama White-Hammond, offered comments about the BLC backlog, and expressed concerns regarding the accessibility of the second floor.

Paul Chung, City Registar, wanted to provide comment and echo the Chief, showed images of the 2nd floor, overview of the city services provided on the 2nd floor, request that we do not landmark the second floor, because this building can not reach across the counters due to tall counters, constituent services overview, constituent feedback not in favor of current layout. We could talk through the operational flexibility that the city can have.

Gary Wolf, spoke in support of historic preservation. We are in full support of the changes that have been proposed, and with respect to the comments that the adjustments required for everyday practicality are certainly something that most of us architects and preservationists will consider with respect to the significance of



the building and the spaces that are there.

Dorothy Clark, many people have a limited and narrow view about landmarking. Instructed to violate the enabling legislation. Landmarking does not take precedence over making places accessible to people.

Eamon Shelton, property management, can count him as an advocate who is in favor of landmarking the building. Object to landmarking the 2nd floor.

Mark Pasnik, I'm an author of one of the authors of the Conservation Management plan, and I just don't know if the amendments to include space can be adapted in some way. But I would encourage looking at the Camp itself, because it actually encourages fixing issues of handicap accessibility. And it also has a way of
