6:05 PM: Commissioner Walker called the public hearing to order. <u>25.0881 BLC - CHRISTIAN SCIENCE CHURCH COMPLEX, 250</u> <u>MASSACHUSETTS AVENUE</u>- At plaza: Replace three diseased Linden trees.

25.0855 BLC - OLD NORTH CHURCH, 193 SALEM STREET - Installation of security cameras at exterior elevations of buildings.

25.0848 BLC - OLD SOUTH MEETING HOUSE, 310 WASHINGTON STREET - At exterior: Restore corner lamp on the Washington Street/Milk Street corner of Old South Meeting House.

25.0849 BLC - OLD SOUTH MEETING HOUSE, 310 WASHINGTON STREET - At interior: Replace existing 1990s pendant lights with Monterey Hanging Lanterns

25.0857 MHT - 15 WIGGLESWORTH STREET - At garden level: dig window well around the center bay window, build a retainer wall using red brick or cinder blocks, enlarge central casement window height but maintain identical width, and install a new casement window.

V. ADVISORY REVIEW

ADDRESS: BOSTON CITY HALL

Applicant: City of Boston

Proposed Work: Proposed alterations to the fourth floor terrace, including changes to central skylight and gridded skylights. Proposed alterations to existing ramps and staircases at the fourth floor terrace. Proposed alterations to south plaza, including ramps and staircases.

PROJECT REPRESENTATIVES:

DOCUMENTS PRESENTED: Documents presented included existing condition photographs, existing and proposed site and floor plans, proposed rendering images, and skylight details.

DISCUSSION TOPICS: Discussion topics included an overview of the existing conditions, accessibility requirements, an overview of the current drainage system and locations of current water damage, an overview of the proposed work to repair existing leaks and water, the proposed work to modify existing ramps to meet accessibility requirements, the existing and proposed materials for skylight, the height of the existing skylights, and the ceiling height differences between the existing fourth floor terrace and South plaza, details regarding the height and material of handrails for the proposed ramps, proposed lighting details for the fourth floor terrace, the proposed material and alternative materials for the vertical wall infills, and the visual impact of the proposed work from the interior.

PUBLIC COMMENT: There were no public comments.
