I. BOSTON LANDMARKS COMMISSION BUSINESS HEARING 6:00 PM

6:13 PM: Commissioner Walker called the public hearing to order. He explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public hearing was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. He also briefly explained how to participate in the online hearing. There were no members of the press present.

III. ARTICLE 85 DEMOLITION DELAY HEARING

ADDRESS: 36 AKRON STREET, ROXBURY

Proposed demolition of 36 Akron Street | Discussion and Vote

PROPERTY REPRESENTATIVE: Andrew Melton was the property representative.

DOCUMENTS PRESENTED: Documents presented included existing condition photographs and aerial maps.

DISCUSSION TOPICS: Discussion topics included the historical and architectural significance of the property and the location of the property.

COMMISSIONER COMMENTS AND QUESTIONS: Commissioners discussed the existing conditions, the architectural significance of the property, and whether the applicant submitted a structural assessment demonstrating the integrity of the building underneath the vinyl siding.

PUBLIC COMMENT: Three written comments and a petition with twenty-three signatures were submitted in support of invoking the demolition delay.

Anthony Fugate, owner of the property, spoke in support of the demolition.

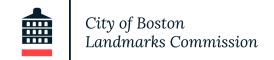
Butch Matthews, construction manager for the property, spoke in support of the demolition.

Proposed demolition of 1558 Tremont Street | Discussion and Vote

PROPERTY REPRESENTATIVE: John Pulgini was the property representative.

DOCUMENTS PRESENTED: Documents presented included existing condition photographs and aerial map images.

DISCUSSION TOPICS: Discussion topics included an overview of the existing conditions, an overview of the architectural and historical significance of the property, a summary of the history of the use for the property, and an overview of the alterations and additions made at the property since its construction.

COMMISSIONER COMMENTS AND QUESTIONS: Commissioners discussed the applicant connecting with staff to investigate the possibility of preserving additional elements of the property.
