

# BOSTON LANDMARKS COMMISSION PUBLIC HEARING MINUTES

#### I. DESIGN REVIEW SUBCOMMITTEE 5:00 PM

**5:05 PM**: Commissioner Berarducci called the Design Review Subcommittee public hearing to order. He explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public hearing was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. He also briefly explained how to participate in the online hearing. There were no members of the press present.

Following this brief introduction he called the first Design Review application.

## APP # 26.0153 BLC ADDRESS: COMMONWEALTH AVENUE MALL

Applicant: Liza Meyer

Proposed Work: Commemorative signage on the Arlington Street Fence at the Mall.

**PROJECT REPRESENTATIVES:** Liza Meyer, of the Friends of the Public Garden, was the project representative.

**DOCUMENTS PRESENTED:** Documents presented included presentation with photographs and photosimulations.

**DISCUSSION TOPICS:** Discussion topics included the placement of the plaque on





the existing granite post, either facing north (towards the walkway entrance) or west (facing inwards onto the mall). Plaque to be permanently mounted, granite surface to be smoothed to receive plaque.

**COMMISSIONER COMMENTS AND QUESTIONS:** Commissioners discussed locations for installing the plaque on either the facing north/threshold side of the post, or on the west/inward facing side. They also discussed that the granite post is a later addition to the Mall and is not part of a historic fence and therefore doesn't set a precedent with signage. There was some concern about the grinding off of the rough stone, and the threat of the plaque being stolen. The commissioners inquired about the material of the sign, which will be true bronze. Commissioners decided to recommend approval with the provisos that the plaque be placed on the west (inward) side of the granite post and that details of plaque and mounting are remanded to staff.


