Discussion: Public Presentation of Cases and Communication

Board discussed clarity in presenting cases publicly, particularly regarding the communications specialist role, to ensure the media accurately reflects public findings. Board further discussed proactive transparency to avoid misrepresentation and noted that community complaints to OPAT reflect mistrust in BPD Internal Affairs, and diverting findings and ethical considerations of involving Internal Affairs Division (IAD) in CRB recommendations. OPAT presented guidance on amendments to advance the process.
