I. VIOLATIONS SUBCOMMITTEE 4:30 PM

4:30 PM: Commissioner Demetriades called the Violations Subcommittee public meeting to order. She explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public meeting was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. She also briefly explained how to participate in the online hearing. There were no members of the press present.

Following this brief introduction she called the first violation.

VIO # 25.0907

ADDRESS: 358 MARLBOROUGH STREET

Proposed Work: At rear elevation unapproved expansion and replacement of windows and entry door; and unapproved paving.

PROPERTY REPRESENTATIVES: Guy Grassi and Thomas Calus were the property representatives.

DOCUMENTS PRESENTED: Documents presented included previous and existing condition photographs, and plans of the previously proposed work.

DISCUSSION TOPICS: Discussion topics included the current condition of the rear elevation, district guidelines regarding rear elevations, a summary of the Commission's previous decisions and provisos, an overview of all unapproved alterations, previous denials of the landscape plans, material of the existing pavers,



the existing location of mechanical equipment, details regarding the lowering of the sills, and an overview of the condition of the rear facade before it was altered, and discussions regarding a new landscape plan.

PUBLIC COMMENT: Alice Murphy, a representative from the Neighborhood Association of the Back Bay, offered comments regarding the violation.

Sue Prindle, spoke in support of the violation going to the full Commission.

Serge Savard, a representative from the Neighborhood Association of the Back Bay, spoke in support of the violation going to the full Commission.

Laurie Thomas, offered comments regarding other violations at the property.

COMMISSIONER WEINTRAUB MOTIONED TO CONTINUE THE REVIEW OF THE VIOLATION. COMMISSIONER SAMPSON SECONDED THE MOTION. THE VOTE WAS 3-0-0 (Y: ID, DS, RW) (N: NONE) (ABSTAIN: NONE).

- That the applicant submit a full landscape, rear yard and facade plan to the Architectural Commission for further review.

ADDRESS: 384 MARLBOROUGH STREET

Proposed Work: Unapproved changes to rear landscape plans approved by the BBAC in 2023.

PROPERTY REPRESENTATIVE: Tarek Hassan was the property representative.

DOCUMENTS PRESENTED: Documents presented included previous and existing condition photographs, and plans of the previously proposed work.

DISCUSSION TOPICS: Discussion topics included existing conditions, the Commission's previous decisions, an overview of all unapproved changes made at the rear, the existing concrete paving material, the proximity of the concrete in relation to the existing trees, the health condition of the trees, whether the applicant consulted with an arborist and the Back Bay Garden Club, the visibility of the existing mechanical equipment, district guidelines regarding landscapes, fencing and paving materials.

PUBLIC COMMENT: Written comment submitted by Charles Shuroff.

Serge Savard, representative from the Neighborhood Association of the Back Bay, spoke in support of the violation going to the full Commission.

ADDRESS: 246 BEACON STREET (CONTINUED FROM 11/13/2024):

Applicant: Eric Hersum

Proposed Work: At roof replace copper balustrade with a polymer stone material.

PROJECT REPRESENTATIVES: Eric Hersum and Bruce Miller were the project representatives.

DOCUMENTS PRESENTED: Documents presented included existing condition



photographs and plans for proposed work.

DISCUSSION TOPICS: Discussion topics included an overview of the existing conditions, whether the existing balustrade was repairable, plans to replicate the existing balustrades with a polymer stone material, the proposed balustrade dimensions and design, visibility of the proposed work, and method for installing new balustrades.

PUBLIC COMMENT: Serge Savard, representative from the Neighborhood Association of the Back Bay, spoke in support of the Commission and staff being involved in inspecting the balustrade prior to installation.

COMMISSIONER HIGH MOTIONED TO APPROVE THE APPLICATION WITH PROVISOS. COMMISSIONER SAMPSON SECONDED THE MOTION. THE VOTE WAS 9-0-0 (Y: ACP, KC, ID, ZG, TH, TN, FR, DS, RW) (N: NONE) (ABSTAIN: NONE).

- *Approved, based on staff's evaluation that the original balustrade has deteriorated beyond repair, with the proviso that the proposed polymer stone balustrade must match the exact dimensions and design details of the existing copper balustrade and be a cream color that matches the stonework of the building, to be confirmed by staff before and after installation.*

The Chair announced that the Commission would next review Administrative Review/ Approval applications.
