**COMMITTEE HEARING NOTICE**

The Boston City Council's Committee on Ways and Means will hold a hearing on **Wednesday, May 27, 2026 at 2:00 pm** in the **Iannella Chamber, 5th Floor, Boston City Hall**. This hearing was previously scheduled for Wednesday, May 27, 2026 at 10:00 am.

The subject of the hearing is:

***Docket #1031, Message and order authorizing the City of Boston to appropriate the amount of Twenty-Two Million Eight Hundred Forty-Five Thousand Six Hundred Seventy-Two Dollars (\$22,845,672.00) for purposes of funding Boston Public Schools to meet operating expenses of the fiscal period commencing July 1, 2025, and ending June 30, 2026. This appropriation request was approved by the Boston School Committee on May 6, 2026, and is intended to cover projected deficits in health insurance (\$18,087,750.00) and utility spending (\$4,757,922.00).***

This matter was sponsored by Mayor Michelle Wu and was referred to the Committee on May 20, 2026.
