FATHER WILLIAM HAS A STRONG PASSION FOR PEOPLE AND URBAN COMMUNITIES AND HIS DESIRE TO SERVE AS A VOICE TO THOSE THAT DON'T HAVE ONE AND TO DEVELOP THEIR OWN WITHIN SOCIETY.

I THINK IT'S \$31,122,743 FOR THE BOSTON PUBLIC SCHOOLS FOR THE FY-18 TO COVER COST ITEMS CONTAINED WITHIN THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE BOSTON SCHOOL COMMITTEE AND THE BOSTON TEACHER'S UNION, LOCAL 66 AFT NORTH AFLCIO.

THE TERMS OF THE CONTRACT ARE SEPTEMBER 1, 2016 THROUGH AUGUST 31, 2018.

THE MAJOR PROVISIONS OF THE CONTRACT INCLUDE A BASE WAGE INCREASE OF 2% IN SEPTEMBER OF 2016 AND 3% IN SEPTEMBER OF 2017.

THE FY-18 BUDGET REQUEST INCLUDED FOR COLLECTIVE BARGAINING, A SEPARATE APPROPRIATION FOR COLLECTIVE BARGAINING INCREASES, A SEPARATE ORDER HAS BEEN FILED TO SUPPORT \$20 MILLION OF THE SUPPLEMENTAL REQUEST.

THE REMAINING \$11 MILLION WILL BE SUPPORTED WITH OTHER GENERAL REVENUE.

MESSAGE AND ORDER TO REDUCE THE APPROPRIATIONS FOR THE RESERVE FOR COLLECTIVE BARGAINING BY \$20 MILLION TO PROVIDE FUNDING FOR THE BOSTON SCHOOL DEPARTMENT FOR THE FY-18 COST ITEMS CONTAINED WITHIN THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE BOSTON SCHOOL COMMITTEE AND THE BOSTON TEACHER'S UNION LOCAL 66 AFT-MASS AFLCIO.

BEFORE I'D RECORD OUT, I LIKE TO ACKNOWLEDGE IN ATTENDANCE THE PRESIDENT OF THE BOSTON TEACHER'S UNION, JESSICA TANG.

[APPLAUSE]

THE COMMITTEE ON WAYS AND MEANS HAD A MEETING SEPTEMBER 27th. WE HAD TESTIMONY ON BEHALF OF THE ADMINISTRATION. NEGOTIATIONS FOR THIS CONTRACT LASTED A REPORTED 18 MONTHS AND THE TOTAL COST OF THE TWO-YEAR CONTRACT IS \$42.7 MILLION. PROCEDURALLY SPEAKING, DOCKET 1249 APPROPRIATES THE FUNDS AND DOCKET 1250 MOVES FUNDS FOR THE SCHOOL BUDGET FOR DISPERSAL. THE FY-18 APPROPRIATION OF \$31 MILLION WILL BE FUNDED WITH \$20 MILLION FROM THE COLLECTIVE BARGAINING RESERVE AND THE REMAINING BALANCE OF \$11 MILLION WILL BE FUNDING FROM \$10 MILLION IN INCREASED RESOURCES FROM PROPERTY TAXES, PARTICULARLY NEW GROWTH, AND THE REMAINING 1.1 MILLION COMING FROM INCREASED BUILDING PERMIT REVENUES. THE CONTRACT HAS A SERIES OF COST FACTORS INCLUDING BASE INCREASE, 2% EFFECTIVE THE FIRST PAY PERIOD IN SEPTEMBER OF 2016, 3% INCREASE EFFECTIVE THE FIRST PAY PERIOD IN SEPTEMBER OF 2017, COST OF LIVING ADJUSTMENT WILL ALSO BE APPLIED TO ALL RATES AND DIFFERENTIALS IN THE PRIOR CONTRACT, INCLUDING HEALTH AND WELFARE CONTRIBUTIONS AS WELL AS SCHEDULE A EXTENDED TIME PAYMENT. IT ALSO PROVIDES ACCESS FOR PROVISIONAL TEACHERS AND PARA PROFESSIONALS IN YEAR TWO AND THREE TO BE ADDED TO THE PARENTAL NEW POLICY. PARA PROFESSIONALS, SUBSTITUTES WILL SEE AN INCREASE IN COMPENSATION FROM \$6 TO \$9 PER HOUR FOR SCHOOL YEAR 2017 TO 18 AND \$10 PER HOUR ON 8-21-18. THE CONTRACT ALSO INCLUDED LANGUAGE AND POLICY MODIFICATIONS THAT ADDRESSES FOR MALLIZATION OF MUTUAL CONSENT FOR HIRING TEACHERS AND THE REMOVAL OF A \$1,250 STIPEND ASSOCIATED WITH OPEN POSTING

POSITIONS.

BOSTON IS THE FIRST TO CODIFY MUTUAL CONSENT HIRING IN THE COUNTRY AND REMOVING THE STIPEND WILL SAVE BPS \$500,000.

ALSO ACHIEVES DISCRETION TO STAFF PARA PROFESSIONALS AND SUPPORTING STUDENTS WITH AUTISM. IT WAS THE RETURNING SERVICE PROVIDERS THAT COULD QUALIFY FOR REIMBURSEMENT VERSUS NEEDING TO PROVIDE ITEMIZED REIMBURSEMENT FORMS.

IT PROVIDES SUBSTITUTE TEACHER COVERAGE FOR INDIVIDUALIZED TESTING IN GRADES 2-3, EXTENDED TO INCLUDE TWO ADDITIONAL DAYS ANNUALLY FOR DUEL LANGUAGE PROGRAMS, TESTING IN TWO LANGUAGES.

AND REPURPOSES TEACHER FUNDING TO BE ALLOCATED BY A JOINT BPS-BTU PANEL SURROUNDING HIGH QUALITY ASSESSMENT HEARS. DISCUSSION INCLUDED MANY OF THE ITEMS LISTED ABOVE AND ALSO INCLUDED STATUS OF TEACHERS IN THE BPS SYSTEM.

THE PAYMENTS WERE DISCUSSED AND IT WAS REPORTED IT WOULD NOT AFFECT THE EPEG SCHEDULE. TEACHERS, SUBSTITUTE TEACHERS, NURSING, PARA PROFESSIONALS AND APPLIED BEHAVIORAL ANALYSIS SPECIALISTS WERE ALL REPRESENTED.

AS CHAIRMAN OF THE COMMITTEE ON WAYS AND MEANS, I RECOMMEND PASSAGE OF THESE DOCKETS.

I RISE TO SUPPORT DOCKET 1249 AND COMMEND OUR COLLEAGUES YESTERDAY.

WE WANT TO EMBRACE SOME OF THE REFORMS IN THE CONTRACT THAT WERE ADDRESSED AT YESTERDAY'S HEARING.

ALSO TO COMMEND OUR TEACHER'S UNION, JESSICA TANG IS HERE. HAD A TREMENDOUS EVENT OVER THE WEEKEND.

IT WAS THE ANNUAL BACK TO SCHOOL BOOK FAIR.

COUNCILLOR ESSAIBI-GEORGE SAID THERE WERE OVER 40,000 BOOKS. EACH KID AND SOME PARENTS GOT 15 BOOKS EACH.

THERE WERE LOTS OF SERVICES BEFORE AND AFTER SCHOOL PROGRAM SERVICES.

SO ALL OF THE SUPPORT SERVICES THAT WE NEED FOR OUR FAMILIES, FOR OUR CHILDREN AND PARENTS AND ALSO FOR GRANDPARENTS RAISING THEIR GRANDCHILDREN.

I FULLY SUPPORT OUR COLLEAGUE, COLOR CIOMMO'S RECOMMENDATION AND GO ON RECORD SUPPORTING DOCKET NUMBER 1249.

COUNCILLOR JACKSON, YOU HAVE THE FLOOR.

>> THANK YOU, MADAM PRESIDENT.

I WANT TO THANK COUNCILLOR CIOMMO FOR THE HEARING THAT ALLOWED US TO HASH OUT WHAT THIS CONTRACT MEANS.

I WANT TO OFFICIAL CONGRATULATE JESSICA TENG AND HER TEAM FOR BEING ELECTED AND THE SERVICE THAT YOU HAVE DONE PRIOR.

I ENJOYED WORKING WITH THE BTU AND THE NO UNQUESTION TOO BECAUSE I BELIEVE THAT HAS A DIRECT REFLECTION IN OUR BUDGET ON AN ANNUAL BASIS IN TERMS OF THE RESOURCES THAT WE HAVE OR DON'T HAVE.

I WOULD ALSO NOTE, WE STILL ARE STAFFING NURSES IN A FACTION, NOT AS A WHOLE PERSON.

WE'RE NOT -- ONE PERSON CANNOT BE IN TWO PLACES AT ONE TIME. EVEN SOMEONE WHO IS MY SIZE. WE NEED TO HAVE A NURSE IN EVERY SCHOOL AND WE KNOW THAT WE HAVE MANY YOUNG PEOPLE WHO SUFFER FROM TRAUMA.

MANY OF THEM AND WE KNOW THAT THE REASON WHY -- THE GREATEST REASON WHY YOUNG PEOPLE STAY BACK FROM HEALTHCARE REASONS IS ASTHMA IN THE BOSTON PUBLIC SCHOOLS.

SO THAT IS A CRITICAL COMPONENT.

I THINK THAT IS ACTUALLY LACKING.
WE'RE MAKING PROGRESS.
WE NEED MORE PROGRESS.
IN ADDITION, IT'S CRITICAL THAT WE HAVE REFORMS WITH TEACHERS.
I WANT TO SEE THOSE TEACHERS PUT BACK TO WORK AND PUT IN CLASSROOMS AND STAFF SO THAT THE SCHOOLS -- I'VE BEEN TO MANY SCHOOLS IN THE CITY OF BOSTON. THEY ARE SAYING THAT THEY'RE UNDERSTAFFED.
LAST YEAR BASED ON THE STAFFING ISSUES, WE HAD SOME DANGEROUS SITUATIONS THAT HAPPENED IN SOME OF OUR SCHOOLS WHERE THERE ARE STUDENTS AS WELL AS TEACHERS THAT WERE HARMED IN THOSE SITUATIONS BECAUSE WE DO NOT HAVE THE STAFFING.
SO IT IS ABSOLUTELY CRITICAL THAT WE MOVE -- BY THE WAY, WE'RE PAYING FOR THE SBC TEACHERS.
