The Boston City Council's Committee on Ways and Means will hold a public hearing on **Monday, October 15, 2018 at 2:00 p.m.** in the Iannella Chamber, Boston City Hall, Fifth Floor.

The subject of the hearing is:

**1441** Message and order approving an appropriation of One Hundred Five Million Four Hundred Thousand Dollars (\$105,400,000.00) from the Surplus Property Disposition Fund, for the purpose of providing funding for the completion of the City's signature open spaces, the Emerald Necklace and funding to the Boston Housing Authority to support redevelopment of communities at Old Colony in South Boston and Orient Heights in East Boston.

This matter was sponsored by Mayor Martin J. Walsh, and referred to the Committee on October 3, 2018.
