On June 20, 2019, the City of Boston ("City") filed a request with the Department of Public Utilities ("Department") for approval of a municipal aggregation plan pursuant to G.L. c. 164, § 134. General Laws c. 164, § 134 authorizes a municipality to procure electric supply on behalf of consumers within its municipal borders through a municipal aggregation program. Eligible electricity consumers not already enrolled with a competitive electric supplier would be automatically enrolled in the municipal aggregation program unless they chose to opt-out, in which case they would continue to receive basic service provided by their electric distribution company, NSTAR Electric Company d/b/a Eversource Energy.

As part of this filing, the City seeks a waiver on its own behalf and on behalf of the competitive electric supplier(s) chosen for the municipal aggregation program, of certain information disclosure requirements contained in G.L. c. 164, § 1F(6) and 220 CMR 11.06(4)(c). The Department docketed this petition as D.P.U. 19-65.

The Department will conduct a public hearing to receive comments on the proposed municipal aggregation plan. The hearing will take place on **Tuesday, August 20, 2019 at 2:00 p.m.**, at the Department's offices located at One South Station, 5th Floor, Boston, Massachusetts 02110. Any person who desires to comment may do so at the time and place noted above or may submit written comments to the Department not later than the close of business (5:00 p.m.) on **August 20, 2019**.

An original hard copy of all written comments must be filed with Mark D. Marini, Secretary, Department of Public Utilities, One South Station, 5th Floor, Boston, Massachusetts 02110. A copy of all written comments must also be sent to Sarah A. Smegal, Hearing Officer at the Department of Public Utilities. One copy of all written comments should also be sent to counsel for the City's agent, James M. Avery, Esq., Pierce Atwood LLP, 100 Summer Street, Boston, Massachusetts 02110.

All documents should also be submitted to the Department in electronic format using one of the following methods: (1) by e-mail attachment to dpu.efiling@mass.gov and to the Hearing Officer, Sarah A. Smegal, Sarah.Smegal@mass.gov, or (2) on a CD-ROM. The text of the e-mail or CD-ROM must specify: (1) the docket number of the proceeding (D.P.U. 19-65); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. The electronic filing should also include the name, title, and telephone number of a person to contact in the event of questions about the filing. The electronic file name should identify the document but should not exceed 50 characters in length. All documents submitted in electronic format will be posted on the Department's website: <http://www.mass.gov/dpu>.

Petition of the City of Boston for approval by the Department of Public Utilities of a municipal aggregation plan pursuant to G.L. c. 164, § 134.

The City of Boston ("City") shall, no later than **August 2, 2019**, publish the attached Notice of Filing and Public Hearing ("Notice") in: (1) The Boston Globe; and (2) the Boston Herald.

In addition, no later than **August 2, 2019**, the City shall serve a copy of the attached Notice on the Attorney General of the Commonwealth of Massachusetts, Massachusetts Department of Energy Resources, Low-Income Weatherization and Fuel Assistance Program Network, Massachusetts Energy Directors Association, and NSTAR Electric Company d/b/a Eversource Energy.

Finally, the City shall from **three days** following the receipt of the Notice from the Department through **August 20, 2019**: (1) post a copy of the attached Notice in a conspicuous location in Boston City Hall; and (2) prominently display the attached Notice on the City's website (<http://www.boston.gov/>), including, without limitation, on its Home page under "Latest News" or "Upcoming Events" and on its Public Notices page.

The City is directed to make proof of publication and return of service at the time of the public hearing.
